The Judge John Price award recognizes the Eagle Scout who is selected as the Crossroads of America council's outstanding Eagle Scout from the year prior to the nomination deadline.

Judge Price was a longtime Scout and adult Scouter who earned his Eagle Scout Award in Troop 10 in Michigan City, Indiana. He presided as a Marion County Superior Court Judge. Judge Price served in numerous Scouting roles, including Scoutmaster, North Star District Chair and council board member. He also earned several Scouting awards, including the Silver Beaver Award. This scholarship was established in celebration of his life and many accomplishments.

Application Deadline for 2022 Eagle Scout: **January 21, 2023**

Selection Process:

- An Scout who passed an Eagle Scout board of review in the Crossroads of America council in 2022 completes the application.
- The application must include the completed form and at least one letter of recommendation from an individual unrelated to the Scout who is familiar with the Scout's leadership and accomplishments.
- The Scout may attach additional documentation or letters if desired.
- The selection committee will consider all aspects of the youth's leadership and participation in Scouting, school, community activities, and faith practice.
- Finalists will be invited to participate in an interview.
- The Judge John Price Eagle Scout of the Year award is presented at the annual council awards dinner.
- The accompanying \$1,000 college scholarship is paid directly to the institution in which the candidate enrolls.

The application may be submitted either in person, by mail, or by email. It must be *received* not later than January 21, 2023 to be considered.
